- Shares were issued upon the vesting of certain RSUs originally granted under the EIP on March 15, 2021. One third of the total grant vested on January 3, 2022, based upon the Reporting Person's continued employment.
- Shares were issued upon the vesting of certain Performance Stock Units ("PSUs") originally granted under the EIP on March 6, 2019, and February 28, 2020, each as modified. The PSUs vested on January 3, 2022, based upon attainment of performance goals certified by the Compensation Committee of the Issuer's Board of Directors and the Reporting Person's continued employment.
- Shares otherwise issuable were withheld to satisfy the Reporting Person's tax obligations arising from the vesting events described in notes 1-4 above.
- Does not include Shares issuable upon future vesting of equity grants, including 37,108 Shares issuable based upon continued service and 63,447 Shares issuable upon attainment of performance goals at target, which, when combined with the ownership reported above, would represent a total of 121,546 Shares.
