The PSUs vested based upon attainment of performance goals as certified by the Issuer's Compensation Committee of the Board of Directors (the "Committee") and the Reporting Person's continued employment.
- Shares otherwise issuable were withheld to satisfy the Reporting Person's tax obligations arising from the vesting events described in note 1 above.
- Does not include shares issuable upon future vesting of equity grants, including 24,325 shares issuable based upon continued service and 24,321 shares issuable upon attainment of performance goals at target, which, when combined with the ownership reported above, would represent a total of 121,189 shares.
