The grant was made pursuant to the AMC Entertainment Holdings, Inc. 2013 Equity Incentive Plan. For additional information on the PSUs, please see the Issuer's Current Report on Form 8-K filed with the SEC on March 3, 2020.

2. The PSUs will vest upon attainment of a 20-day volume weighted average closing price ("VWAP") of \$12 for the Issuer's Class A Common Stock.

3. The PSUs will vest upon attainment of a 20-day VWAP of \$16 for the Issuer's Class A Common Stock.

4. The PSUs will vest upon attainment of a 20-day VWAP of \$20 for the Issuer's Class A Common Stock.

5. The PSUs will vest upon attainment of a 20-day VWAP of \$24 for the Issuer's Class A Common Stock.

6. The PSUs will vest upon attainment of a 20-day VWAP of \$28 for the Issuer's Class A Common Stock.

7. The PSUs will vest upon attainment of a 20-day VWAP of \$32 for the Issuer's Class A Common Stock.
